#### 2. Previous Minutes

## 2. Treasurer's report

- 2.1. See appendix for details.
- 2.2. GRP confirmed final bursary rider had reported back and GS confirmed final payment instalment had been made

# 3. 2022/23 Prize and trophy presentation event.

- 3.1. Tally Ho has been booked & GS made initial deposit payment balance to be confirmed closer to the date.
- 3.2. 100 ticket sales so far (31 children 71 adults) need to push the sales. Cut-off date for the final numbers at the venue is 6<sup>th</sup> March.
- 3.3. Action GRP to make big splash on deadline for tickets to be bought by 3rd March 2023
- 3.4. GRP doing PPT presentation to be displayed on the screen. GRP will provide a script.
- 3.5. GS & HJ volunteered to identify and direct prize winners to the stage on the day.
- 3.6. GRP & GS confirmed prize fund is £5,416.
  - First £30 + zip tights (£100 value)
  - 2<sup>nd</sup> £70
  - 3rd £60
  - 4th £40
  - 5<sup>th</sup> £30
  - 6<sup>th</sup> £20
  - 7th £10
- 3.7. GS 2022 madison Money was lumped in and bumped prizes up to £7,000
- 3.8. Cash prize fund will be £5,724 if balance of Madison money is included.
- 3.9. GRP wanted confirmation that the previous system of awarding equal prize money for positions would apply i.e. equal money for placings but different depths depending on the number of riders.
- 3.10. GRP asked MD to provide category listing in 5 year age groups that would exclude non-league registered riders.

- 3.11. IR discussed use of images of children in a rolling presentation to be prepared by Debbie Homer. GRP read the BC guidance which suggested that in-race photos were, ME suggested that BC Compliance officer be contacted. MH did not consider that a closed private function was problematic.
- 3.12. MH is happy to publish the final prize list including the MSW youth who changed teams half way through the league.
  - GRP confirmed Solihull won the main league & Newport SCC won the u12 league.
- 3.13.32 categories (3 prizes per category) to be presented and timetable discussed.
  - 12.30 for 1pm start until 5pm when we must leave.
  - Bar 1pm-4.30
  - SP suggested breaking for food at 2.30-3.15pm

#### 3.14. Costing

- Room hire:
  - £630 for the day
- Catering:
  - 300 people
- Ticket revenue
  - Discussion over ticket pricing.
    - Consequences of spending too much
    - Separate fees for adults/children
    - Buffet is at least £12pp and we will heavily subsidise the food (and event)
    - £5-10pp ticket discussed.
    - Rider HQ will be used for booking and the league
  - It was agreed that tickets should be £5 for children and £7.50 for adults.
- 3.15. Master of ceremonies:
  - DM spoke to Nick Jeggo and he & Di Jeggo can do the MC in return for expenses and buffet.
- 3.16. Action HJ to email the Jeggos with details.

## 4. League equipment

- 4.1. Agreed this should be postponed to the next meeting for proper discussion but a protocol for handover and expectations should be determined prior to next season.
- 4.2. Action JP looking for someone to store the PA batteries in reasonably warm dry conditions to ensure their preservation. Currently stored in the spare room that is soon to be occupied.

- 5.1. AGM booked from 1-5pm on Sunday 28th May.
  - Action GS to see if we can get earlier access to set-up.
  - Action SP volunteered to arrange catering
- 5.2. MH suggested broadening the scope of the committee beyond event organisers.
- 5.3. HJ standing down as Secretary.

- 6.1. IR wanting to discuss courses for new events. Courses over the previous 20 years have become less interesting
- 6.2. GRP suggested encouraging existing clubs to look at alternative venues but these can be improved.
